Among the qualifications required are:

Candidates must be regularly employed in the functional group they desire to represent. They must be and have been members in good standing in NABET-CWA continuously for the three years immediately prior to the date of nominations. In the case of Daily Hire members, "regularly assigned" to the Local Executive Board Unit shall mean that they have worked in the Local Executive Board Unit for which they are a candidate for at least 130 working days within the last 365 days on the final day of submission of petitions for the office.

Petitions must contain signatures (and printed names) of not less than twenty (20) active members in good standing in the Local as of the date petitions are due.

These original petitions, along with an optional brief biography (Section 7.3(C) of the Local By-Laws), must be in the Union Office by 4:00 PM, Thursday, February 18, 2010.
