**TO: All NABET-CWA Local 11 Active Members and Retirees**

Please be advised that the applications for the Local 11 Scholarship Awards (\$500.00 per year) are now available at the Union office, 145 West 30<sup>th</sup> Street, 12<sup>th</sup> Floor. They can be picked up Monday thru Friday from 8:30AM - 3:30PM. They are also available on the NABET-CWA Local 11 website at: [www.nabetlocal11.org](http://www.nabetlocal11.org).

The following are the eligibility requirements for the Local 11 Scholarship Award:

- 1) The Award is open to any retiree or active member of Local 11 in good standing. The member or retiree may apply for himself or sponsor a member of his immediate family (wife, husband, son or daughter).
- 2) The applicant must presently be a fully matriculated graduate or undergraduate student at any accredited college, institute, university or any other facility of higher learning.
- 3) This Local 11 Award shall be granted only once to any applicant, but no other Award would be a cause of ineligibility.

**REQUIREMENTS**

- 1) Applicants must submit proof of present attendance at the school of higher education, i.e., copy of Fall 2009 or Spring 2010 Bursar's or Registrar's receipt.
- 2) Applicants must sign the disclaimer attached to the application.
- 3) To qualify, all forms must be completely filled out.

**TERMS**

- 1) The Award is good for a maximum of 4 years within a 5 year continuous period and may be used in combination (if needed) of undergraduate and graduate work if the applicant has less than 4 years of undergraduate work remaining and is accepted for graduate study.

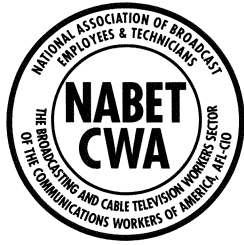
**METHOD OF SELECTION**
