The eligibility requirements for the scholarship are:

- 1. The scholarship is open to all active members in good standing, active retirees, and their sons and daughters who are either in, or about to enter, an accredited college or trade school.
- 2. Applicants who are in high school must be graduating in 2020.
- 3. The award is a one-time \$1000.00 payment to be used for tuition or other expenses to the school designated by the winner.

The return date for the preliminary application is February 14, 2020. All applications must be verified by the Local President, in the space provided before mailing to the Sector office at NABET-CWA, 501 Third Street NW, 6<sup>th</sup> Floor, Washington, DC 20001.
